Vendor Fees for 2011

Indoor Vendors are divided into four basic categories: **Non-Food, Packaged Foods** (including chips, cookies, pastries, candies, preserves, salsas, sodas, etc.), **Bulk Foods** (including dairy, eggs, meats, seafood, produce, herbs, spices, nuts, grains, pastas, etc.), **Prepared Foods** (hot and cold food items prepared on the premises).

Indoor Vendors must commit to either a 6- or 12-month contract in order to reserve an Indoor Stall Location. Indoor Vendors must also commit to opening their business every day the market is open, or they will be fined \$50. A Contract Renewal Fee of \$25 is required for renewing 6-month contracts. All Indoor Vendors are also required to pay a Monthly Utility Fee of \$20 (Non-Food Vendors) or \$40 (All Food Vendors).

One month’s rent and one month’s deposit are due upon signing of contract.

Vendor Statement of Understanding

Vendor understands that Vendor Stall Fees are due by the 25th day of the preceding Month. Vendor understands that each Stall Fee is for one 8'X8' space, and that Stall Fees may be raised as outlined in the 2011 Othello Public Market Rules and Regulations.

Vendor has read and understands the 2011 Othello Public Market Rules and Regulations and is bound by the terms and conditions outlined in them. Vendor is responsible for making sure staff/family who work at the market read and understand the Rules and Regulations. Vendor will sell only approved products and services that are listed on this application. Vendor understands responsibility to collect and report Washington State Sales Tax.

Vendor understands that Product Liability Insurance is required for all processed and prepared food including fish, meats, dairy, preserves, pasta, baked goods, etc. Vendors are responsible for the quality and safety of what they sell. Vendor shall indemnify, keep and save harmless the El Mercado, PC and all agencies the El Mercado, PC has agreements with (including the City of Seattle and Othello Partners) from and against, any and all claims and demands, whether for injuries to persons, or loss of life, or damage to property, on or off the premises, arising out of the use or occupancy of the premises by Vendor, and shall defend at Vendor’s own expense any action brought against the El Mercado, PC and any of the above mentioned organizations or any other person or organization with which El Mercado, PC has a contractual relationship by Vendor’s acts or omissions.
